Nicola and Mike will be highlighting the challenges the community on Windmill Hill face and ask the businesses to make a pledge on how they can help the community.
- What can we ask the businesses for? How can we help them? Could Windmill Hill be used to pilot projects? e.g. roll out of 4G? more training to help employment (HGV licences)? help with business planning for new business start-ups? help with PR, social media and communication? Be great if the Partnership can meet the businesses on the 4<sup>th</sup> from 9.55 – 10.00am at the CC..

## **Big Local Officer Group Meetings (BLOG)**

- BLOG obviously want Big Local to succeed, is it a model that could be replicated across Halton? No need for BLOG to be 'hands on' – but strategic support, funding expertise etc would be welcome. DE to inform Shelah Semoff to arrange a January BLOG meeting.

- Any ideas for the Active Communities Fund please let DE know. One idea is to fund expertise for the production of the newsletter, website, social media, etc. Fund journalism, photography, design skills for local people? Timebank support from the Mersey Gateway? Need professional guidance to get it set up. Local Trust expertise nationally see what is available. OBA Academy have students that may be interested in developing a newsletter a real project. Are any of the individuals attending the 'Seeing is Believing' have a PR, communication background?
